BALLOT FOR EXECUTIVE COMMITTEE ELECTION, JULY 13, 1985.

ACCORDING TO THE STATUTES AND RULES OF PROCEDURE OF IASPM (8.3.), THE EXECUTIVE COMMITTEE SHALL HAVE NOT LESS THAN NINE (9) MEMBERS AND NOT MORE THAN FIFTEEN (15). AS OF JUNE 13, 1985, THE DATE FOR THE CLOSE OF NOMINATIONS, SIXTEEN (16) NOMINATIONS HAD BEEN RECEIVED BY THE EXECUTIVE SECRETARY. THESE SIXTEEN (16) NAMES ARE LISTED IN ALPHABETICAL ORDER BELOW. YOU MAY VOTE FOR UP TO FIFTEEN (15) OF THESE PEOPLE BY PUTTING A CROSS (X) IN THE BOX OPPOSITE THEIR NAME.

YOU MAY HAVE MORE THAN ONE VOTE BY VIRTUE OF VOTING AS A PROXY, OF VOTING ON BEHALF OF AN INSTITUTIONAL MEMBER, OR OF VOTING ON BEHALF OF AN ACCREDITED BRANCH COMMITTEE. VOTING ACCREDITATION MUST HAVE BEEN PREVIOUSLY ESTABLISHED IN WRITING WITH THE INTERNATIONAL MEMBERSHIP SECRETARY. IF THIS IS THE CASE, YOU MUST FILL OUT A SEPARATE BALLOT IN EACH OF THE CAPACITIES FOR WHICH YOU HAVE A VOTE.
