CONFERENCE UPDATES

Next conference: The Northern and US branches expressed interest. The local and the international conferences could merge. Conference dates: 2022, 2024.

BOOK PRIZE

The deadline for the concepts was March 29. About to start the second round of Book Prize. If the verdict is not ready by the General Meeting, it can be announced later in an extra research seminar. The videos could be put on the web on the YouTube IASPM account. For future Book Prize events, it might be a good idea to allocate prizes in different branches to account for the linguistic diversity and have an international award.

STATEMENT ON DIVERSITY

CS is drafting a statement with the aid of Tami Gadir and BG to be presented next month. To be approved, it could be adopted into statute or procedures and sent a month before the general meeting to the secretary.

SOCIAL MEDIA

Crystal circulated a document analyzing the media involvement by region. The largest participation happens in the UK, Ireland, the US, and Brazil; the rest of the world has smaller numbers. Therefore, Crystal and her team are focusing on promoting participation from the areas with the least involvement. There are 2900 followers on Facebook, much less on Twitter, and 52 on YouTube. The April plan is to email the branches promoting the email, set up by KK, to send announcements and info to be spread out. After the first three months, they will focus on English, Portuguese, and Chinese; then, in Spanish, Arabic, and Russian. They will promote the research seminars on Twitter and will include Instagram and WeChat for China and LinkedIn. They want feedback from the EC. RT will write saying that their plan seems fine and will give them access to membership numbers to track the social media impact on membership. BS will provide that info.
